

## SCIENTIFIC PAPER PRESENTATION GUIDELINES

### International Society of Hypertension and Argentine Society of Hypertension AWARD

1. All abstracts must be submitted via SAHA webpage ([www.saha.org.ar](http://www.saha.org.ar)) under the tab "Congresos SAHA"/ "XXX Congreso, Córdoba 2024"/ "Resúmenes de Temas Libres"/.
2. To submit an abstract, you must register as an author. You will receive an access code by e-mail. With this code you will be able to access the system at any time until the abstract submission deadline. **(January 31, 2024)**.
3. Follow the instructions on the screen at each step.
4. The body of the abstract is limited to 2,000 characters (not counting spaces).
5. A table or figure may be included and should be added using the option provided by the system. The table must be simple and not exceed the maximum size of 5 columns by 8 rows and a maximum of 100 characters, in order to be published.
6. Once the form has been sent, you will receive a confirmation on the screen that it has been correctly received and a confirmation number.
7. This confirmation represents only the receipt of the work and does not imply its approval or acceptance.
8. Authors may click the box ISH-SAHA and choose among these awards:
  - Premio Internacional (ISH-SAHA) al Mejor Trabajo de Investigación Básica en Hipertensión Arterial. Award value: USD 500 or its equivalent in Argentine pesos according to the Argentine Republic Central Bank Exchange rate at the time of the award payment.
  - Premio Internacional (ISH-SAHA) al Mejor Trabajo de Investigación Clínica en Hipertensión Arterial. Award value: USD 500 or its equivalent in pesos according to the Argentine Republic Central Bank exchange rate at the time of the award payment.
9. An extended summary must also be sent (maximum of 1,000 words without counting title, authors or institution to which they belong) and up to two (2) tables and/or figures, in total. The title must be in capital letters and without abbreviations. Next, the authors and the place where the research was carried out. The text should describe: objectives, materials and methods, results and conclusions. This extended summary should be uploaded to the system in Word format at the time of sending the abstract.

**The paper presented herein cannot be presented to the other SAHA awards.**

10. Requirements:
  - Abstract and oral presentation shall be presented only in English.
  - Abstract requirements are placed in SAHA website under the window "INSTRUCCIONES PARA EL ENVÍO DE RESÚMENES" (Instructions for abstract submission).
11. Qualifying papers will receive between 0 and 10 points (10 is the highest score).
12. The top 5 qualifying abstracts submitted for an oral presentation in each category will compete for the Best Basic and Clinical Research Paper on Hypertension (ISH-SAHA International Awards) and will be presented in an oral session only. Presenters will have 10 minutes of speaking time plus 5 minutes for discussion. Papers not eligible for this award will be presented as posters in the regular sessions.
13. All abstracts submitted to the awards will be evaluated by a panel of judges appointed by the Argentine Society of Arterial Hypertension (SAHA) and the International Society of Arterial Hypertension (ISH). 3 judges will be appointed for the best Basic research paper on

hypertension (ISH-SAHA International Award) and 3 judges for the Best Clinical Research Paper on Hypertension (ISH-SAHA International Award). These judges must not be authors or co-authors of the mentioned articles. In addition, they must not have a conflict of interest or work in the institution where the research was carried out.

14. Deadline for submission is **January 31, 2024** at midnight (Argentina time).
